1. Acknowledgment of Risks

I acknowledge that renting and riding a bicycle is a hazardous activity, that involves inherent risks, including falls, collisions, and accidents with other bicyclists, motor vehicles, or stationary objects, and widely variable conditions of the trail, road or pavement, that may result in injury or death. Understanding the nature of cycling and e-biking, I confirm I am qualified, in good health, and in proper physical condition to participate. I will discontinue participation if I believe conditions are unsafe. I acknowledge that injuries in this activity are common, and I freely accept and voluntarily assume these risks. I have been advised that as a condition of each bicycle being lent to me, I must wear a helmet at all times while riding and I agree to do so. I also understand that bicycles are subject to all laws and rules of the road and I agree to abide by them whenever riding on public land and roadways. Initials: _____

2. Waiver of Liability

In consideration of renting equipment from LBC, I RELEASE AND AGREE NOT TO MAKE ANY CLAIM AGAINST OR SUE LBC. I release, indemnify, waive, and hold harmless LBC, it's owners, employees, agents, and any affiliated entities from any and all responsibility or liability for any injuries, damages, loss, or death resulting from my participation in the use of the rented equipment, whether by negligence of the company, breach of contract, or any other legal theory. I agree to indemnify the company for all attorneys' fees, costs, or judgements incurred. I accept this equipment "as is" with NO WARRANTIES, express or implied. Initials: _____

3. Responsibility for Equipment

I accept full responsibility for the bike and equipment. I will return it in the same condition as received, normal wear and tear excepted. I am responsible for any loss or damage and agree to pay for repairs or replacement at the full retail value, as well as for the full rental value of any additional time or days beyond the agreed return date. I acknowledge that I will be charged the full retail value of any rental/demo equipment that is not returned due to loss, damage or theft. I will be the only person who rides the rental/demo bike, and I am obligated to immediately report any loss, damage, or mechanical failure to LBC. Initials: _____

4. Compliance with Laws

I agree to comply with all local laws while riding the rented bicycle and using the rented equipment, including wearing a helmet at all times and abiding by all laws relating to where I am riding. Initials: _____

5. Equipment Use and Safety

I understand how the equipment works and have received satisfactory instructions and answers to all my questions regarding the use and function of the bicycle, including, without limitation, the

pedal system and quick release mechanisms, gears, control console, and braking mechanisms. I will not make adjustments to the bicycle beyond the instructed settings. I agree to check the equipment before each use and will stop using it if it appears to malfunction. I understand it is not possible to predict every situation and condition of the terrain the bike will be ridden on; therefore, it is impossible to guarantee the bike I use will react safely in all riding conditions. I understand that a properly fitted helmet may reduce the risk of some injuries but that serious injury or death can still occur. I understand that cycling is hazardous, and I EXPRESSLY AGREE TO ASSUME ALL RISKS of injury or death while using this equipment, including the negligence of others.
